

## **2012 DISTRICT MEETINGS Locations & Directions**

**District #1A – Friday, February 17, 2012, White House Lodge, 1450 Veterans Dr., Richland Center, WI 53581.** Located on HWY 14 East, Directly behind Hardees off of HWY 14 East in Richland Center (east side of city).

**District #1B – Saturday, February 25, 2012, North Star Conference Center, 5025 CTH V, De Forest, WI 53532.** Follow Interstate 90/94/39 until Exit 126, turn west onto CTH V, hotel is one block ahead on left.

**District #2A – Friday, February 10, 2012, The Plaza Hotel & Suites, 1202 W. Clairmont, Eau Claire, WI 54701.** I-94, exit HWY 37 north, go ½ mile, located at the intersection of US 12 and HWY 37.

**District #2B – Saturday, March 3, 2012, The Eagle's Club, 1104 W. Oak Ave., Marshfield, WI 54449.** Coming in on HWY 13 North of HWY 10, turns into Central Ave., (Roddis Ave.), go to 1<sup>st</sup> set of lights, turn left on 14<sup>th</sup> St., go to Oak St., turn right, down 2 blocks on the left, next to Melody Garden Skateland OR coming in on HWY 13 South or HWY 97, turns into Arnold St., go to 2<sup>nd</sup> set of lights, turn right onto Oak Ave., on right hand side of road.

**District #2C – Saturday, March 31, 2012, Fox Hollow Banquet Hall, N3287 CTH OA, La Crosse, WI 54601.** Located between West Salem and La Crosse, From I-90 go west on CTH C, at stop sign go left on CTH M about 4 miles, at stop sign go right on CTH O, located at corner of CTH O & OA.

**District #3A – Saturday, February 4, 2012, Rumors (Northwoods Conf. Center), 23986 St. Rd. 35 South, Siren, WI 54872.** Located at the junction of HWYS 70/35 and CTH B in the quaint village of Siren in Burnett County.

**District #3B – Saturday, March 10, 2012, Lakewoods Resort & Lodge, 21540 CTH M, Cable, WI 54821.** From HWY 63, turn east on CTH M, approximately 8 miles.

**District #3C – Friday, March 30, 2012, Centennial Community Center, 412 E. Centennial Ave., Stetsonville, WI 54480.** HWY 29 west to HWY 13 north, turn east on Stetsonville A, go 3 blocks on left.

**District #4A – Saturday, February 18, 2012, Holiday Inn Hotel & Convention Center, 1001 Amber Ave., Stevens Point, WI 54481.** On the east side of Stevens Point. Just east of I-39 take Exit HWY 10 East, proceed approximately 2 miles east to Convention Center, which is located just north of HWY 10 East.

**District #4B – Friday, March 9, 2012, Arbor Vitae Community Center, 10675 Big Arbor Vitae Rd., Arbor Vitae, WI 54568.** From HWY 51 & HWY 70 East, take the 4<sup>th</sup> left off of HWY 70 East, which is Big Arbor Vitae Rd., Town Hall is the first driveway on the right.

**District #4C – Friday, March 23, 2012, Potawatomi Carter Casino, 620 HWY 32, Carter, WI.** Located on HWY 32, between Townsend and Wabeno on the east side of the highway.

**District #5A – Friday, February 24, 2012, Comfort Suites/Royal Ridges Conf. Center, HWY 23 West, Ripon, WI 54971.** Located on the west side of Ripon, look for the large blue sign across from Pick-n-Save.

**District #5B – Friday, March 16, 2012, The MARC, 3177 French Rd., De Pere, WI 54155.** Take HWY 41, exit CTH S, go east, turn right onto French Rd. to the Marc.

**District #5C – Saturday, March 24, 2012, Bil-Mar Supper Club, 3627 CTH CR, Manitowoc, WI 54220.** Take CTH CR (old HWY 141) south from HWY 151 approximately ½ mile east of I-43 on west edge of Manitowoc.

**District #6A – Saturday, February 11, 2012, Juneau Community Center, 500 Lincoln Dr., Juneau, WI 53039.** From north: into Juneau on HWY 26, go to 2<sup>nd</sup> stop sign (M&I bank on left), turn left 2 blocks turn right (Mill St.) 2 blocks turn right (Lincoln St.), 1 block on left OR From south: on HWY 26, go to 4-way stop (M&I bank kitty corner), proceed straight on Mill St.

**District #6B – Saturday, March 17, 2012, City Limits at Jansen's, 1245 Whitewater Ave., Fort Atkinson, WI 53538.** Located on the southeast side of Fort Atkinson on HWY 12.
