## NEW CLASS A AFFILIATE MEMBERSHIP OPTION

Class A affiliate members<sup>1</sup> will continue to be required to pay a \$50 membership fee to receive a hard copy of the magazine and receive information library access. Electronic access log in credentials for current Class A members were provided directly to you via USPS. **NOW CLASS A AFFILIATE MEMBERS CAN INSTEAD PAY ONLY \$25 TO RECEIVE THE SAME INFORMATION LIBRARY ACCESS AND THE ELECTRONIC MAGAZINE** (instead of the hard copy). ## NEW CLASS B AFFILIATE MEMBERSHIP OPTION

Class B affiliate members<sup>2</sup> will continue to be required to pay a \$175 membership fee to receive a hard copy of the magazine and receive information library access. Electronic access log in credentials for current Class B members were provided directly to you via USPS. **NOW CLASS B AFFILIATE MEMBERS CAN ALSO PAY ONLY \$50 PER ADDITIONAL LOG IN TO EXPAND ELECTRONIC ACCESS IN YOUR COMPANY.** If you are eligible for Class B affiliate membership and would like to receive the hard copy/electronic magazine and members only access to the information library, or if you are a current Class B member and would like to add access log in credentials, please contact Chris Loesl, 715-526-3157 or [chris.loesl@wisctowns.com](mailto:chris.loesl@wisctowns.com). <sup>1</sup> Class A affiliate members include town or village officials and employees of WTA member governments, such as, planners, zoning administrators, fire personnel, police personnel, sanitary district commissioners, highway superintendents, plan commissioners, etc. For purposes of electronic access, current recipients of a complementary hard copy magazine, administrators, deputy clerks, and deputy treasurers receive complementary log in credentials.

<sup>2</sup> Class B affiliate members include private sector businesses, such as, attorneys, engineers, planners, etc. The \$50 per additional log in is available after the initial \$175 fee.
